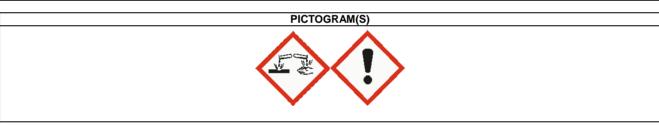

4. FIRST AID MEASURES

Inhalation: Move to fresh air. If breathing is difficult, give oxygen. If not breathing, give

5. FIRE FIGHTING MEASURES

6. ACCIDENTAL RELEASE MEASURES
